CONTRACT AGREEMENT

THIS AGREEMENT made the 23rd day of May, 2022 between NATIONAL **BOHOL-CEBU-SIQUIJOR** ADMINISTRATION, IRRIGATION MANAGEMENT OFFICE (BOHOL-SIQUIJOR OFFICE), Dao District, Tagbilaran City, Philippines (hereinafter called "the Entity") of the one part and OCCIDENTAL ENTERPRISES of Tagbilaran City, Bohol, Philippines (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, particularly Furnishing of Construction Materials for Pangaonan-Magsaysay SIP, Sevilla, Bohol with Contract No. BCSIMO-GOODS-17-2022 and has accepted a Bid by the Supplier for the supply of goods and services in the sum of Two Million Eight Thousand Nine Hundred Eighty Four Pesos (Ph 2,008,984.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Two Million Eight Thousand Nine Hundred Eighty Four Pesos (Ph 2,008,984.00) or such other sums as may be ascertained, OCCIDENTAL ENTERPRISES agrees to Furnishing of Construction Materials for Pangaonan-Magsaysay SIP, Sevilla, Bohol in accordance with his/her/its Bid.
- 4. The National Irrigation Administration, Bohol-Cebu-Siquijor Irrigation Management Office (Bohol-Siquijor Office) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
